

OFFICE ORDER

Sri Swarup Ranjan Sahoo, S/o. Sri Niranjan Sahoo, AT: Hinjalkhal, PO: Jillinda, Cuttack, Odisha - 754032 is hereby **provisionally appointed as Jr. Engineer (Civil) (Class-III)** against backlog vacancy **under OBC category** in the pay scale of Rs. 19,100 - 51,100/- with usual IDA and other allowances as sanctioned by the Board from time to time, **with following terms and conditions**

- 01] **This appointment is purely provisional**, subject to verification of his educational/ Community certificates/verification of character and antecedents. If the verification reveals that the claim to belong OBC is false, his/her services will be terminated forthwith without assigning any further reasons and without prejudice to such further action as may be taken under the provisions of the Indian Penal Code for production of false certificates.
- 02] **He will be on probation for a period of 02(two) years** from the date of joining in the post under Regulation-19 of Paradip Port Trust Employees (Recruitment, Seniority and Promotion) Regulations, 2011.
- 03] He should report for the duty to the Chief Engineer, Paradip Port Trust within 15(fifteen) days from the date of issue of this order, failing which the offer of appointment will be treated as cancelled under Regulation-17 of Paradip Port Trust Employees (Recruitment, Seniority and Promotion) Regulations, 2011.
- 04] He should submit the Medical Certificate of fitness from the Paradip Port Trust Hospital at the time of joining. He may contact the Chief Medical Officer, PPT in this regard for obtaining the Medical Certificate.
- 05] He has to submit attested copies of Certificates in respect of his Educational Qualifications/Community status to the Chief Engineer, PPT. The OBC candidate has to submit latest caste certificate with creamy layer exemption.
- 06] He should submit the attestation form duly filled in along-with two pass-port size photographs to the Chief Engineer within one month from the date of joining in the post **for verification of character and antecedents**.
- 07] He should submit Character certificate from two Gazetted Officers of State/Central Government (if not submitted) along-with the declaration regarding marital status at the time of joining.
- 08] No Travelling Allowance is admissible for joining the post.
- 09] The contributory pension scheme as applicable with effect from 01.01.2004 at Paradip Port Trust is applicable to him.
- 10] This appointment is purely temporary and terminable at any time without assigning any reason on giving one month's notice in advance or one month's salary in lieu thereof by either side. No prior notice of termination will, however, be given in the event of termination under Regulation-21 of Paradip Port Trust Employees (Recruitment, Seniority and Promotion) Regulations, 2011. The appointment shall be regulated by the same Regulation, 2011.
- 11] **The above appointment is subject to the final outcome of Civil Appeal No.3989-4000 of 2012, W.P.(C) No.3127 of 2008, W.P.(C) No.9366 of 2018 and W.P.(C) No.1382 of 2018 respectively.**
