
- 01] **This appointment is purely provisional**, subject to verification of his/her educational/Community certificates/verification of character and antecedents. If the verification reveals that the claim to belong SC/ST/OBC is false, his services will be terminated forthwith without assigning any further reasons and without prejudice to such further action as may be taken under the provisions of the Indian Penal Code for production of false certificates.
- 02] **He/She will be on probation for a period of 02(two) years** from the date of joining in the post under Regulation-19 of Paradip Port Trust Employees (Recruitment, Seniority and Promotion) Regulations, 2011.
- 03] He/She should report for the duty to the Chief Mechanical Engineer, Paradip Port Trust within 15(fifteen) days from the date of issue of this order, failing which the offer of appointment will be treated as cancelled under Regulation-17 of Paradip Port Trust Employees (Recruitment, Seniority and Promotion) Regulations, 2011.
- 04] He is required to submit the Medical Certificate of fitness from the Paradip Port Trust Hospital at the time of joining. For the purpose, he will be referred to the Port Trust Hospital at Paradip Port on his reporting to Chief Mechanical Engineer,PPT.

- 05] He/She has to submit attested copies of Certificates in respect of his/her Educational Qualifications/Community status to the Chief Mechanical Engineer, PPT.
- 06] He/She should submit the attestation form duly filled in along-with two pass-port size photographs to the Chief Mechanical Engineer within one month from the date of joining in the post **for verification of character and antecedents.**
- 07] He/She should submit Character Certificate from two Gazetted Officers' of State/Central Government along-with the declaration regarding marital status at the time of joining.
- 08] No Travelling Allowance is admissible for joining the post.
- 09] The contributory pension scheme as applicable with effect from 01.01.2004 at Paradip Port Trust is applicable to him/her.
- 10] This appointment is purely temporary and terminable at any time without assigning any reason on giving one month's notice in advance or one month's salary in lieu thereof by either side. No prior notice of termination will, however, be given in the event of termination under Regulation-21 of Paradip Port Trust Employees (Recruitment, Seniority and Promotion) Regulations, 2011. The appointment shall be regulated by the same Regulation, 2011.
