Circular

Sub: Care of critically ill patients-Referrals

It need not be overstated that critically ill patients received in the PPT Hospital need utmost care. Recently, complains have been received that referral of the patients to higher centres is getting delayed.

At present, the EMO alone, if convinced or in consultation with the concerned specialist can refer a critically ill patient to the higher centre without the approval of the Sr. Dy. CMO/CMO.

Here, a crucial decision has to be taken, whether the patient requires to be stabilized before transferring to a higher centre. Sometimes, it may so happen, transfer of a critically ill patient may get delayed due to the emergency preliminary treatment/resuscitation that may invite criticism.

Therefore, it is instructed that while utmost care is to be taken to arrive at the best possible provisional diagnosis and start appropriate treatment/resuscitation, there must be good communication with the patient and their relatives at each stage, i.e. starting from resuscitation to referral/treatment in PPTH. The patient and their relatives must be a part of the decision making in such cases.

If, the patients and/or their relatives want a critically ill patient to be shifted immediately against medical advice of preliminary treatment/resuscitation, the same must be recorded and their signature be taken to avoid future dissatisfaction/complain.

It is reiterated that in all such critical cases, who requires referral; where an accurate diagnosis cannot be made and where the symptoms persists, in spite of the best of the efforts, the EMO/specialist are empowered to take a decision on referral of the patients to higher centres. In all such cases, permission of CMO/Sr. Dy. CMO need not be sought. It may only be informed later on for post-facto approval.

Any violation of this circular will be viewed seriously and the concerned doctors will be held responsible for any untoward incidence.




