**Engagement of Advisor (Legal) at Paradip Port Authority on Contractual basis**

(1) Paradip Port Authority intends to engage a retired Judicial Officer (not below the rank of District Judge) as Advisor (Legal) on **Contractual basis** in Paradip Port Authority for a period of one year on the following terms & conditions:-

**i) Age:- Not to exceed 70 years.**

**ii) Remuneration:- Rs.1,50,000/- (Consolidated) per month.**

**(2) Other conditions:**

- The contract Period will be of one year and extendable further, based on the performance and requirement, at discretion of the Port.
- Paradip Port Authority quarters may be provided, subject to availability, on recovery of usual charges as applicable to Port Officers.
- Hired vehicle, as admissible to Port Officers may be provided for use of official purpose.
- The selected candidate will be eligible to get admissible TA/DA as applicable to Port Officers when deputed outside the Head Quarter on Official Duty.
- Medical facility for the family including referral- as applicable to Port Officers subject to surrendering the medical facilities availed from the State Government or he/she may be allowed to continue the medical facilities from the State.
- Weekly-off, closed holidays, national holidays and CL, as applicable to Port Officers, will be admissible with prior permission of Secretary/reporting HoD. The working days/hours would be at par with Port employees/Officers and there is no provision for any extra remuneration if the work is done beyond office hours/holidays.
