N.B. :

- (i) **This result is purely provisional.** The selected candidates have to attend for verification of documents and they have to produce all original certificates/documents for verification. Only after physical verification of all certificates/documents and after fulfillment of recruitment rules, then only final selection will be made. This result will not give any right to the candidates for claiming appointment in PPT.
- (ii) Certificate verification for candidates will start from last week of May,2018. Exact date and time will be published on this website. Candidates are advised to refer this website accordingly.
- (iii) The name of candidates selected against backlog vacancies are not considered for current vacancy. However, if there is shortfall against backlog vacancies, candidates shown against current vacancies will be adjusted against backlog vacancies.
- (iv) As per rules, Backlog vacancies will be filled up first. Thereafter, current vacancies will be filled up.
- (v) After verification of the certificates/testimonials if some candidates are not found to be eligible, then, subsequent list will be displayed on the website, as per requirements.
- (vi) If any candidate is selected against 2 posts, then option will have to be exercised, as per extant rules.
- (vii) Ex-Servicemen should fulfill R.R. condition and age limit as per prevailing rule, failing which they will not be considered.
- (viii) For Sports persons, candidates are required to fulfill RR condition and they will have to produce relevant certificates in support that they represented State/Nation, failing which they will not be considered.
- (ix) SC/ST candidates have to produce original latest caste certificate and OBC candidates have to produce non-creamy layer certificates (latest).
- (x) SC/ST/OBC if availed age relaxation will be considered against reserved post only.
- (xi) The eligibility will be determined strictly as per RR. The decision of chairman is final, in case of any dispute in this regard.
