Further to the Notice dated 04.03.2024 at Sl. No.(5) under reference as per Clause-17 of the above referred work order i.e. **Termination of Contract**, your reply is not satisfactory. Even after expiry of 01(one) Month of above Notice, you have neither rectified the Boat nor deployed the substitute vessel for which the operational activities of the Port hampered a lot.

Therefore, the contract along with the Agreement for "Hiring of 01 No. Mooring Launch along with Operational crew for daily one shift operation for a period of seven years" is hereby Terminated with immediate effect along with forfeiture of Security Deposit of Rs. 39,10,680/-, submitted by your firm in shape of Bank Guarantee No. 122GT02192140001 dated 02.08.2019.

Further, you are hereby debarred from participating in any Tender of Paradip Port Authority for a period of 03 (three) years.
