OFFICE MEMORANDUM

Sub: Simplification of procedure for treatment at private Empanelled Hospitals of PPT.

The Chairman, Paradip Port Trust has been pleased to approve adoption of OM No.Z15025/105/2017/DIR/CGHS/EHS dated 09.11.2017 of Central Government Health Service, simplifying the procedure for treatment at private empanelled hospitals of PPT.

Consequent upon which, the Medical Officers of Paradip Port Trust Hospital shall not refer the beneficiaries to any particular empanelled hospital by name and shall **specify the treatment procedure** and mention referred to **any PPT empanelled referral centre**. As a result of which, a beneficiary, who is a normal resident of a particular city/twin city, can choose a referral hospital of PPT for his/her treatment. If the beneficiary chooses a hospital in another city/state for his/her treatment, even if, the same is available in his/her city of residence, according to MH & FW O.M No.S11011/06/96-CGHS (P) dated 11.07.1997, Clause No.2 (v), he/she will not be eligible for TA/DA. Further, according to Clause No.2 (vi) of the same O.M., he/she has to get permission of the appropriate authority for availing such treatment in another city.

The beneficiary shall ascertain that the ailment, for which he/she seeks treatment in a particular hospital, is in fact available in the hospital and is also empanelled for the same.

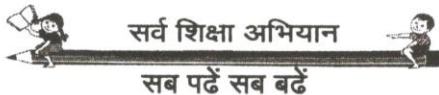
The list of PPT empanelled hospitals is available in the Reception Section of PPT Hospital, displayed in the Lobby of the Hospital and available in the PPT Website under the menu "Concerns & Care" and sub-menu "Medical facilities."

The empanelled hospitals, providing cashless/credit facility as per the MOU, shall perform the treatment. The beneficiary choosing treatment in PPT empanelled hospital which is not providing cashless facility has to pay the treatment cost to the hospital directly and apply for the reimbursement at CGHS rate.
