E-tender Call Notice

1. Electronic Tenders are invited from the Firms pre-qualified/registered with PPT Hospital, as per list (Annex-A), in single-stage-single-bid system up to **17.00 hrs. of 20.12.2021** on behalf of the Board of Trustees of Paradip Port Trust for the supply of Surgical Items & Hospital Items, Disposable Needles & Syringes, Suture Materials, IO Lenses & etc. on annual rate contract basis for the finance year 2022-23. The budget for the procurement of, “Drugs/Chemicals/Reagents/Surgical/Lab. Products /Surgical Sundries/ X-Rays Films /ECG Ancillaries/ Appliances/ Instruments /Any other products” for the financial year-2022-23 is Rs 9, 10, 90, 824-00.
2. The Firms registered with the Paradip Port Trust Hospital can only submit their quotations for the supply of Surgical Items & Hospital Items, Disposable Needles & Syringes, Suture Materials, IO Lenses & etc. through online bidding on the website <https://eprocure.gov.in/eprocure/app>. They should possess Digital Signature Certificate (DSC) issued from any agency authorized by Controller of Certifying Authority (CCA), Govt. of India and can be traced up to the chain of trust to the Root Certificate of CCA. The DSC shall be used to authenticate their tenders (offers).
3. The registered Firms need to create their own User ID & password to log on the e-Tendering system (Please see information to the bidders).
4. The quotations shall be submitted “online” strictly in accordance with the instructions to the vendors, and on the given terms & conditions. The registered Firms have to agree to all the terms & conditions for the submission of electronic tenders including the uploading of price bids. The price bid can be uploaded at anytime and/or modified any numbers of times before the due date and time of closing of tender.

11. The bidder must possess compatible Digital Signature Certificate (DSC) of Class-II or Class-III for participation in the tender.
12. All Bids are to be submitted online on the Website <https://eprocure.gov.in/eprocure/app>. No Bid shall be accepted off-line. The Bids shall be received **only "online" on or before 20.12.2021 up to 17:00 Hours.**
13. The Price-bids of the pre-qualified bidders will be decrypted and opened online on the scheduled date and time by the *Bid Openers* with their Digital Signature Certificate (DSC). The bidders will get the information regarding the status of their financial bid and ranking of bidders on website. Other details can be seen in the bidding documents.
14. The authority will not be held responsible for any technical snag or network failure during on-line bidding. It is the bidder's responsibility to comply with the system requirement, i.e. hardware, software and internet connectivity at bidder's premises to access the e-Tender website. Under no circumstances, the Paradip Port Trust shall be liable for any direct/indirect loss or damages to the bidders incurred by them arising out of incorrect use of the e-Tender system or internet connectivity failures.
15. Clarification, if any, sought by the Tender Inviting Authority (TIA), shall have to be provided by the Firm within the time limit of 72 hours from the time of

sending of e-mail to them for the purpose; failing which, it will be presumed that the Firm has nothing to clarify, and decisions will be taken only on the available information (provided).

16. The Authority reserves the right to reject/cancel/postpone part or whole of the tender at any stage of the tender, without assigning any reasons thereof and shall not be bound to accept the lowest offer, which will be binding on all the bidders.
