CIRCULAR

It has been decided to allot following vacant **damaged quarters** in respect of eligible Port Users under Traffic Department on **option basis**.

The users may give options for all the aforesaid quarters in order of preference (i.e. 1st preference, 2nd preference, 3rd preference... etc.) if they so like. However, the applicant will be considered, as per eligibility, only for those quarters, he has applied for.

Since these are damaged quarters, the same will not be allotted unless a Port User specifically applies for the quarters, even if he is otherwise eligible.

No change (additions/deletions/alterations) in the options will be permitted once the same is submitted. Applications received incomplete and beyond 31/05/2019 will not be entertained.

The Users will have to submit an undertaking in the prescribed format (Sample copy enclosed) before allotment of quarter, that the quarters allotted to them are taken by them on as is where is basis at their risk, cost and responsibility without any liability on the part of Paradip Port Trust and further Paradip Port Trust will not be held responsible for loss/damage to their properties and life for whatsoever reasons during the period of staying in the quarter.

The allotment of above damaged quarters will be made as per the prevailing norms.
