## OFFICE MEMORANDUM

Sub: Revision of PPT Hospital charges for Non-Port Employees.

The Board of Trustee vide Resolution No.27/2021-22 on Agenda Item No.8(2)/2021-22 in the Meeting No. 02/2021-22 held on 28/09/2021 has approved;

i. All treatments\* and investigations are to be processed in CGHS rates of Bhubaneswar, revised from time to time, which will be adopted automatically. CGHS package rates will be the same as defined in CGHS guidelines. The present CGHS rates of 2021 of Bhubaneswar are to be followed.

(\*Clarification: OPD consultations with in-house doctors will be free.)

- ii. OPD charge of visiting consultant (when allowed) will be as per CGHS rate.
- iii. Ambulance Service: TATA Winger/ FORCE (BLS): Rs 50.00\* per km for the distance covered (One side).
- (\*Clarification: The charges will be revised from time to time, based on changes in fuel prices in the state.)
- [Adopted from the Govt. of Odisha Notification No.TRN-LC-MISC-0028-2021/4467/T.Dated 17/05/2021].
- iv. Mortuary service: Rs 500.00 for 12 hours, or part thereof. One chamber of mortuary can be provided to police free of cost subject to the availability.
- v. Checkups and delivery charges (including bed charges) to married daughters of working employees will be free (they have to bear the costs of medicines, and consumables).
- vi. Medicines and other consumables can be provided to non-port employees in emergencies, and will be charged as per purchase rates.
- vii. Approved Hospital rates will be charged for tests/investigations, where CGHS rates are not available.
- viii. There can be waiver of hospital charges, including treatments to patients, who are unable to pay, and are BPL (have to produce proof) on case to case basis, or treatment of unknown patients in emergency.
- ix. Occupational Health check up: Rs 1,500.00 per person for other organizations.
- x. Other Organizations/Institutions interested in availing treatment at PPT Hospital on debit bill (to be paid within one month of placing bills with them) can be allowed subject to:
  - (a) Earnest Money Deposit of Rs 25,000.00.
  - (b) Treatment at CGHS rates.
- xi. Decision of the Chief Medical Officer, PPT will be final for any dispute arising out of treatment and/or any other accounts (e.g. no CGHS rate for a procedure or investigation).
